Minutes – Town Council Meeting & Public Hearing FY17 Budget June 1, 2016

Mayor Roop called the FY17 Budget Public Hearing to order at 7:00 p.m.

Present: Mayor Roop, Council Members, David Hoffman, Ed Palsgrove, Kimberlee Schultz and Ed Smith. (Councilmember Custen absent) Also present was Town Clerk, Donna Alban, Town Attorney Ostrander and Town Manager, Frank Schaeffer. There were 5 others in attendance.

FY17 Budget Hearing – Mayor asked for questions or comments from the Council and those in attendance, hearing none, A Motion by Councilmember Smith to close the hearing, 2nd by Councilmember Palsgrove and approved 4-0.

Call to Order: Mayor Roop called the Town Council meeting to Order at 7:02 p.m.

Town Manager report:

Lagoon Decommissioning

Service agreement has been signed. EOT was on site in May doing pilot testing on their equipment and flow meter. Town staff will be removing aerators and the curtains from small lagoon in June. Pumping down of clear water in the lagoons will begin the first of August.

Streetscape Planning Assistance

A letter was received from Maryland Department of Transportation Secretary Pete Rahn in follow-up to the April 8th meeting with the top State Highway Administration officials. It was suggested to decrease the size of the water line as means to reduce cost. There has not been an opportunity to evaluate if that is something the Town wants to do.

Spoerlien and Roop Drives Paving.

Service agreement has been signed. Stambaugh's has ordered structures and materials. Town staff is developing a notification to be sent to the affected adjoining property owners to make them aware of the project and the schedule.

Blue Ridge and College Avenues Engineering Study

The report was presented to the Town Council at the May 16th Work Session. There were several areas of concern. The engineer has not been directed to revise the report. The SHA did submit comments on the study. Their comments related to how the drainage would be handled.

Snow Storm Jonas

FEMA has submitted the reimbursement request for approval. The final amount eligible is \$12,861.70. of which 75% would be reimbursed.

Lions Ballfield Project.

The project is out for bid. The pre-bid meeting is June 6th, bids are due June 20th. The project includes repair of the outfield fence and backstop. Replacement of the wall behind the backstop and repair and resetting of the bleachers.
