**MAYOR ROOP'S MESSAGE**

**Grant Updates:**

College Avenue and Blue Ridge Avenue Street Project: The Town submitted a State of Maryland Community Development Block Grant application for the reconstruction of Blue Ridge Avenue & College Avenue. This project would include the construction of ADA compliant sidewalks, new curbing, new storm water management system and repaving of College Avenue and Blue Ridge Avenue. The amount requested was \$673,300.00. We should know the outcome of the application in a few weeks.

Preservation Maryland: Preservation Maryland has been working with the Town to receive funding for a practical and comprehensive study on Dielman Inn. Two grant applications they are working with us will be submitted later this year.

Operating Assistance Grant: The National Center for Smart Growth, University of Maryland was submitting a grant on behalf of the Town. This grant, through the Maryland Department of Housing and Community Development would provide funding for a comprehensive study to incorporate the future growth of the Town and services and infrastructure needed to meet the resident's needs. Again, we hope to hear more about the grant in July.

Dielman Inn update: As I mentioned in the last newsletter, the Maryland Department of Housing and Community Development approved \$143,716 for additional work on the exterior of the Inn. The work began on April 17 and so far, the roof has been painted, shutters have been painted and reinstalled where possible with original hardware. Additional shutters may be hung later using modern hangers. Rain gutters and down spouts have been completed. Chimney repairs; two of three have been repaired. The replacement of a large chimney in the back was scheduled for the week of the June 26. Construction of piers for support columns are also scheduled for the week of June 26.

The largest portion of the lagoon remediation has been completed. G.E. Fielder & Associates has completed three options for the future use of the former lagoon area as well as the surrounding area. The area includes the Lions Club ball field, the lagoon area, public works facility, tennis courts and picnic shelter. We believe this study will provide public works and recreation facilities that will be very beneficial to the town for many years. The three preliminary options will be presented to the council in July.

**Streetscape Project:**

Sewer Line Lining: Work has begun on one of our responsibilities of Streetscape. This project is the lining of sewer lines on High & Main Streets. The lining or cured-in-place pipe (CIPP) system creates a protective, structural pipe inside the existing host pipe system, without digging or destruction to the landscape. Cleaning and inspection of the sewer lines began on June 26. Lining of the sewer lines is scheduled for the week of July 17. There will be periodic short interruptions in sewer service, we will notify everyone when this is to happen and have a schedule posted on the Town's website when work is scheduled.

Waterline Replacement: Engineering of the waterline replacement began on June 8th. The bid for this project will be ready in about a year, with a Notice to Proceed for construction is scheduled for next fall. We will have a community informational meeting this fall.

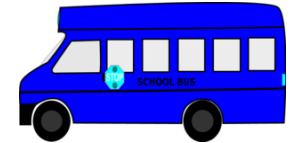

### New Services Available to New Windsor Residents

RSVP Carroll County announces two new services that are now available to help senior and other residents of New Windsor and the surrounding areas.

The Food Pantry at Frederick Scott Key High School, 3825 Bark Hill Road, is now open to all residents **every Tuesday from 3:00-4:00**. Canned goods, bakery items and other pantry staples may be picked up at no cost. It is not necessary to show proof of household income to obtain groceries, and participants are encouraged to take an extra bag of groceries to deliver to a friend or neighbor. To find the Food Pantry, go to the back parking lot of the school and use the entrance near the flagpole.

RSVP Volunteers will deliver groceries to anyone who does not have transportation to get to the school, those over age 55 or those who have physical limitations that make it difficult to carry grocery bags. Call RSVP at 410-386-4646 to request home delivery through **Seniors with Groceries** project.

Transportation assistance is now available to cancer patients who find it difficult to get to their medical appointments. RSVP Volunteers for the American Cancer Society's "Road to Recovery Program" will pick up patients at their home, and provide transportation at no cost to treatment appointments in the county. Call the American Cancer Society at 410-781-6909 to request transportation assistance.

**RSVP** stands for Retired and Senior Volunteer Program, which is a branch of the Senior Corps, a federally supported program through the same agency which administers AmeriCorps and Vista. The program recruits volunteers age 55+ to provide needed services in Carroll County through established non-profits.

RSVP volunteers serve with Meals and Wheels, health and wellness partnerships, soup kitchens, and food pantries to address food insecurity for older, home-bound residents. Many seniors must make the choice between eating healthy food and paying rent or buying critically needed medicine, and RSVP volunteers serve in programs that help seniors to live better, more healthy lives.

RSVP Carroll County addresses the concerns of the community by harnessing the power, wisdom and experience of seniors age 55+. A few minutes or hours per week can make a significant difference in the lives of others.

### New Windsor Quarry Development

Contractor Allen Myers continues to develop the North pit by excavating the top layers of clay, Karst and Phyletic (overburden) materials to obtain the limestone source needed for the cement plant operations. All of the overburden materials are being transported to create the safety/security berm around the property and fill in overburden areas on the North (Rt. 31) and South (Old New Windsor Road) ends of the property. Blasting in the North pit area is ongoing approximately every other day and will continue for the future.

### New Windsor Quarry Maintenance Shop

The steel of the maintenance shop is complete, the roofing materials have been installed and the contractor (J.B. Fay and Sub) are beginning to install the siding and infrastructure. The maintenance shop will provide large and small work bays for maintaining and repairing large and small quarry mobile equipment. The shop will also house the breakroom, washroom and offices for the employees working at the New Windsor Quarry. The entrance road; One Wanner Drive has been complete with the first pour of concrete.

### New Windsor Crusher

The Hazamag impact crusher installation was completed in May. Since the completion the crusher has had several dry runs without stone. All equipment has been test run individually and as a group run. All safety checks and interlocking has been tested and confirmed. The first test run of the crusher with stone is scheduled for July 6.

### Overland Conveyor

All civil work has been completed along the conveyor path. All fields that were disturbed during construction have been reinstated and the farmers have planted crops for the 2017 harvest. The last stream of restoration along Greenwood Church road will be completed by the first week of July.

The conveyor tunnels and jumbo covers are complete and all doors are installed. Mechanically the conveyor is complete. Electrical wires are still being installed to complete the last few instruments over the 4.5 mile run.

The final belt pull of the total 9 miles of belt on the overland conveyor was completed on June 22. After all the electrical work is completed we will begin to perform check out on the conveyor. The team will test every sensor, belt alignment switch, start up alarm and pull cord to insure the safety of the workers before the belt is started. The first belt start is expected to be late July early August.

## Sources of Drinking Water

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

## Lead Prevention

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The Town of New Windsor is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your drinking water, you may wish to have your water tested. Information on lead in drinking water, testing methods, and steps you can take to minimize exposure is available from *the EPA Safe Drinking Water Hotline at 1-800-426-4791 or at <http://www.epa.gov/safewater/lead>.*

## Important information regarding Gross Alpha Emitters:

Alpha emitters are naturally occurring radiations in soil, air and water. These emitters generally occur when certain elements decay or break down in the environment. The emitters enter drinking water through various methods including the erosion of natural deposits. There are no immediate health risks from consuming water that contains gross alpha, however some people who drink water containing alpha emitters in excess of the MCL over many years may have an increased risk of getting cancer. Currently, the highest level of gross alpha detected is 3.6 pCi/L which is below the 15 pCi/L MCL.

# Town of New Windsor 2016 Drinking Water Quality Report



## Important Information About Your Drinking Water

We're pleased to present to you the Annual Water Quality Report for 2016. This report is designed to inform you about the water quality and services we deliver to you every day. Maryland Environmental Service (MES), an Agency of the State of Maryland, operates the water treatment facility and prepared this report on behalf of the Town of New Windsor.

The Environmental Protection Agency (EPA) regulates Public Water Systems and the contaminants found in water through the implementation of the Safe Drinking Water Act (SDWA). The SDWA sets regulations and guidelines for how public water systems operate and identifies several hundred drinking water contaminants, establishes monitoring frequencies and limitations. The Maryland Department of the Environment (MDE) is responsible for the enforcement of the SDWA and routinely complete Sanitary Surveys as part of their ongoing inspection and monitoring program. MES provides safe dependable operations of the water system and is dedicated to consistently providing high quality drinking water that meets or exceeds the SDWA standards.

**T**he Town of New Windsor water works consists of two drilled wells in the Sams Creek Phyllite formation and a natural spring. After water is pumped out of the wells and collected from the spring, disinfectant is added to protect against microbial contaminants. The Maryland Department of the Environment has performed an assessment of the source water. A copy of the results is available. Call *Maryland Environmental Service* at 410-729-8350.

**S**ome people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. ## Town of New Windsor Treated Water Quality Report 2016

### Definitions:

- ◆ *Maximum Contaminant Level Goal (MCLG)* - The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- ◆ *Maximum Contaminant Level (MCL)* - The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- ◆ *Action Level* - The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow
- ◆ *Treatment Technique (TT)* - A required process intended to reduce the level of a contaminant in drinking water
- ◆ *Turbidity* - Relates to a condition where suspended particles are present in the water. Turbidity measurements are a way to describe the level of "cloudiness" of the water.
- ◆ *pCi/l* - Picocuries per liter. A measure of radiation.
- ◆ *ppb* - parts per billion or micrograms per liter
- ◆ *ppm* - parts per million or milligrams per liter



### Special points of interest:

Drinking Water, including bottled water, may reasonably be expected to contain at least small amounts of some compounds. The presence of these compounds does not necessarily indicate that water poses a health risk. More information about contaminants and potential health effects can be obtained by calling the *Environmental Protection Agency's (EPA's) Safe Drinking Water Act Hotline* (1-800-426-4791).

**T**he table on the next page lists all the drinking water contaminants that were detected during the 2016 calendar year. The presence of these compounds in the water does not necessarily indicate that the water poses a health risk.

Unless otherwise noted, the data presented in the table is from testing done January 1 – December 31, 2016. The State requires us to monitor for certain contaminants less than once per year because the concentrations of these contaminants are not expected to vary significantly from year to year.
