The Town of New Windsor (Owner) is requesting Bids for the construction of the following Project:

Blue Ridge Sewage Pumping Station Upgrade

Bids for the construction of the Project will be received at the offices of the **Town of New Windsor** located at **209 High Street, New Windsor, MD 21776**, until **Friday, December 15, 2023** at **10:00 a.m.** local time. At that time, the Bids received will be **publicly** opened and read. The Town Hall is open from 9:00 A.M – 3:00 P.M. Monday through Friday.

The Project includes the following Work:

The functional upgrade of the Blue Ridge Sewage Pumping Station including demolition; replacement of the existing base mounted pumping system and enclosure which includes the fiberglass enclosure, lighting and climate control, two sewage pumps, steel pump base, drives, motors, piping and fittings, valves, motor control panel, level control system, integral wiring, pipe supports, station bypass connection, piping, valves, fittings and appurtenances; rehabilitation and patching of existing concrete; replacement of the wet well hatch, existing controls and electrical system; paintings and coatings; replacement of site fencing, gates and pavement; furnishing and installing pipe bollards; and installation of 80KW generator and automatic transfer switch (ATS) including transporting from the Town's Wastewater Treatment Plant. 80KW Generac generator and ATS are being provided by Kelly Generator and Equipment.
