Call to Order: Work Session Meeting was called to order by Mayor Roop at 7:00 p.m.

<u>Approval of Minutes:</u> Councilmember Holl motioned to approve meeting minutes for September 18, 2023 work session and second by councilmember Gubernatis. Approved 4-0

## **General Fund 6 Year Capital Projects:**

- Paving projects past and future.
- Lion's club retaining wall has been completed.
- Gazebo Park has been completed.
- Waiting on Atlee, Skate Park and Sulphur Springs improvements.

### **Enterprise Fund 6 Year Capital Projects:**

- Water
  - replacing meters, water supply master planning, well exploration.
- Sewer
  - o 10,000 feet of sewer lining, Atlee upgrades, WWTP ENR upgrades.

### MD-31 Updates:

• Wayne and Gary met with Carroll County. Concerns brought up about PRV's and expansion tanks in regard to the meter replacements. Decisions regarding all meters and meter pits are at the discretion of the Town and not the County. The pipeline coming from the Main Spring to the chlorination tank will have possible upgrades.
