<u>Present:</u> The November 6th, 2024, Town Council meeting was attended by, Mayor Neal Roop, Vice-Chair and Councilwoman Kimberlee Schultz, Councilmembers, David Hoffman, Kevin Cornick and William Holl. - MD-31 Water Main Project
 - o Mid-Atlantic Utility remains on schedule. Completion date by early to mid-December of this year.
- Springdale Prep School Building Permit for Windsor Hall
 - o Springdale agreed to pay all fees.
- Frank Schaeffer Memorial 5K
 - o Held Saturday October 19th at Wakefield Vally Park.
 - o 81 participants registered online and 10 walk ups.
- 2021 Lead and Copper Rule Revisions
 - EPA mandated all public water systems in the US to inventory the water service connections. MDE oversees the process for Maryland
 - o Submitted the inventory by the deadline of October 16th, 2024.
 - Must notify water customers whose service lines are either Lead, Galvanized Requiring Replacement of Lead Status Unknown by November 15, 2024.
 - o Letters will go out to approximately 75 residents.

 - Second draft to be presented at a later date.
